Subject:- Rejection of candidature due to non production of Original documents.

Whereas, a total No. of 23117+13253=36370 application forms were received in response to above referenced PHQ J&K advertisement notifications for filling up 1350 posts of Constables in 02 Women Battalions of J&K Police.

Whereas, all the eligible candidates desiring to appear in physical tests were required to bring along with original documents / testimonials for scrutiny on the day of their physical tests as per the instructions contained in the above quoted PHQ J&K advertisement notices.

Whereas, after the culmination of physical tests in all the Districts of erstwhile J&K State now UT, numerous candidates were found to have been deficient in respect of their original documents who were given ample chance to produce their original documents in support of their claim with respect to Age / Residence/ Qualification and Reserved Category (if any), at (PRB Section) PHQ J&K Jammu /Srinagar.

Whereas, inspite of having been given an considerable time to make good their deficiencies, only some of the candidates turned up to produce their original documents. The Police Recruitment Board, in the larger interest of candidates decided to give them one more chance to all such candidates who could not make good their deficiencies. The left out candidates, as such were given one more chance to produce their original documents.

Whereas, after having been given final chance for clearing their deficiencies, (147) candidates were unable to produce their original documents in support of their claim with regard to Residence (Domicile certificate)/Age (DOB certificate) /Qualification (Matric diploma). As such the candidature of these **(147) candidates** whose details are mentioned in **Annexure- "A"** to this order are hereby declared to have been **Rejected** due to non production of original documents mentioned against each.
