

S.No	Specifications	Clarification
1.	Network Standard ONVIF, PSIA, CGI, ISAPI	Any of the standards acceptable
2.	Support H.264+ & H.265	Not limited to any particular standard/support. Bidder can have any of the standards, either separate or in combination.
3.	30m IR Range (Indoor Camera)	Not limited to any range. 30m or 20m acceptable
4.	16 Channel NVR H.265/ H.264+/ H.264/ MPEG 4 Decoding Format	Any standard, either alone or in combination
5.	Network Protocol TCP/IP, DHCP, DNS, NTP, SDAP, SMTP, NFS, UPnP, HTTPS	Not limited to any particular standard
6.	ISO Certification	Where ever mentioned in the tender or amendment notice issued earlier, shall be read as either OEM/Bidder or both shall have ISO Certification.
7.	4/8 port switch	Rates to be quoted for 8 port switch in BOQ. A value of Zero (0) to be filled in relevant column against 4 port switch in BOQ.

NB: Bidder while selecting OEMs of equipments and hardware are advised to avoid those products or OEMs which are suspected to have clandestinely embedded spyware/malicious code either in embedded form or in application software to hack or intercept data including video footages and intrude into the system. In this context, bidders shall refer advisories of bodies like CERT-IN and also reports published in various international media, technical journals, trusted websites etc and other relevant sources.


