

ii.	Rates quoted shall be final till the validity of the contract, i.e. up to 31.03.2020.

15. On due date of opening of tenders i.e. **27.05.2019 at 1100 hours, technical bid only** shall be opened and the technical evaluation process will start. Those who qualify the technical bid will be informed online regarding opening date of financial bid.

16. **Security Deposit:-**The approved supplier will have to supply the BR Land Rover as per approved rate, and specification, till the validity of the contract. They will have to furnish **security deposit @10%** of the total value of the items contracted for in the shape of Call Deposit Receipt valid at Call or FDR valid till 31.03.2020 from a Nationalized/Scheduled Bank, at the time of signing of **Deed of Agreement** to ensure satisfactory performance of the supplied BR Land Rover, for Warranty period from the date of acceptance of product. This security deposit will be released in due course after the expiry of specified warranty period/agreed

Contract. The charges on stamps etc. (cost of documents in totality) shall be borne by the supplier while executing the agreement. (No interest shall be paid by the purchaser on the Security deposit). J&K Govt Rules for Security Deposit in respect of local SSI Units shall be applicable.

Guarantee/Warranty:- Except as otherwise provided in the invitation to the tender, the approved supplier hereby declares that the BR vehicle sold/supplied to the purchaser under this contract shall be of the best quality and workmanship and new in all respects and shall be strictly in accordance with the specifications and particulars contained/ mentioned in the contract. The fabricator hereby guarantees that the said BR vehicle would continue to conform to the description and quality aforesaid for a period as mentioned in the terms and conditions of NIT, from the date of acceptance of supplies by the purchaser. If during the aforesaid period the said BR vehicle are discovered not to conform to the specifications of supply order and quality aforesaid or not giving satisfactory performance or have deteriorated, the decision of the purchaser in that behalf shall be final and binding on the fabricator and purchaser shall be entitled to call upon the supplier to rectify/replace the defective parts or such portion thereof by the contractor and in such an event, the warranty period shall apply to the supplied BR vehicle/parts rectified/replaced from the date of rectification/replacement thereof. In case of failure of the contractor to rectify or replace the defective parts etc within specified time, the purchaser shall be entitled to recover the cost with all expenses from the contractor for such defective parts etc by the available means.

18. **Alternate Guarantee/Warranty:-** The intending Tenderers shall have to provide 05 years "Alternate Guarantee/Warranty" to the fabricated Land Rover, which has to be specially mentioned in the tender offers.

19. **Liquidity Damages:-** Successful tenderer shall have to deliver fabricated vehicle within the stipulated delivery period as would be mentioned in the supply order. J&K Police reserves the right to impose liquidity damages up to 5% of the unsupplied quantity which shall depend upon the nature of supplies, extent of delay.

20. The BR Land Rover fabricated by the successful tenderer shall be surveyed and verified by the J&K Police at stores i.e. Police Central Stores Jammu, as the case may be.

21. As soon as the acceptance of the tender is communicated to the successful Tenderers online, the contract shall be binding on him. The earnest money of the tenderer who backs out or withdraw his tender or fails to abide by it after acceptance thereof is communicated/posted to him shall be forfeited besides other penal remedies that may be available to the Govt. of the J&K under the law for the time being in force in the State of J&K.

22. The successful tenderer shall have to enter into an agreement on prescribed Proforma (immediately after the issue of supply order) with the Department for due performance of the contract which shall be furnished before the BR vehicle are delivered.


23. The tenderer is required to furnish an authenticated copy of Tax clearance certificates (along with the tender offer or at the time of payments) for the year 2018-19 or a year earlier. The PHQ shall be at liberty to put to scrutiny, verification etc. the Tax clearance so furnished by the successful tenderer.

24. The authorities reserve absolute powers to reject or accept any tender or part thereof without assigning any reason and without any legal obligations. Any clause incorporated in the tender (not conforming to the NIT in any manner) shall make such an offer liable for rejection. Therefore, **all the terms and conditions of the tender Notice including technical specifications shall be carefully studied for the sake of complete and comprehensive tender.** Failure to comply with any of the conditions stipulated in the tender or instructions or the offer with insufficient particulars/documents shall lead to out-right rejection of the tender.

25. If after the placement of orders, the tenderer backs out or fail to built-proof BR vehicle, the security deposit/EMD will be forfeited besides all other penal provisions the department may decide to impose as per existing norms.

26. The formal deed incorporating the terms of the contract will be executed by the successful tenderer immediately after receipt of supply order. Failure to execute such bond/deed shall not however prevent the contract from being enforced against the tenderer. Any loss sustained by the Govt. as a result of re-tendering the contract shall be recovered from the defaulter, besides other penal provisions as the department may decide;

	Delivery of BR vehicle:- Bullet resistant vehicle shall be delivered (as per instructions in supply order) at Police Central Store, Gulshan Ground Gandhi Nagar Jammu as the case may be in perfect condition. The fabricator if he so desires may insure the fabricated vehicle against loss or theft, destruction, damages by the natural calamity loss by exposure to weather or otherwise viz. war rebellion, riot etc. The insurance charges will have to be borne by the fabricator and the department shall not pay such charges;
28.	If the successful fabricator fails to fabricate vehicle of the prescribed specification or fails to deliver the fabricated vehicle within the stipulated period as specifically mentioned in the supply order, the department shall be at liberty to arrange fabrication of vehicle from any other source or by re-tendering or otherwise at the risk and cost of the tenderer.
29.	If at any stage of the tender process two or more bidders are found in collusion between/among themselves with intent to reduce competition, set price, share technical expertise, share business information/decision, control/share production and/or distribution of products and raise price, all such tenders shall be out-rightly rejected.
30.	If at any stage of tender process any bidder/s is/are found influencing any Government Servant associated with handling the tender process and supplies thereof, bid of such tenderer/s shall be rejected besides invoking any other provision available under rules.
31.	All legal proceedings arising out of any dispute between the parties shall have to be settled in the Courts situated in Jammu and Srinagar and not elsewhere.
32.	Supplies if deficient in any manner viz-a-viz supply order shall be rejected. Penalty/damages would be imposed and recovered from the bidder as per the terms and conditions indicated in the supply order.
33.	The fabricator shall not sublet the contract or any part thereof to any other agency without prior authorisation of PHQ J&K.
34.	The decision of the accepting authority shall be final as to the quality of fabrication work and shall be binding on the fabricator. In case the fabricated BR vehicle is not according to specifications the same shall be rejected and at our absolute discretion, rejected vehicle may be allowed to be made good by way of replacement. The loss caused due to rejection of the fabricated vehicle shall be entirely borne by the fabricator. The department shall in no case be responsible for any loss or damage that may occur to the rejected vehicle while these are in the premises of the purchaser.
35.	The Department reserves the right to add or suitably modify the terms and conditions (without prior notification) as per exigencies and hence above shall not be construed as all inclusive.
36.	Bidders submitting their bids on-line shall only be accepted and manual bids shall be rejected and no document other than mentioned in the NIT shall be accepted manually.
37.	PHQ may call any bidder at any stage of the tender process for seeking any clarification.
38.	Queries/representations on Tender enquiry received up to pre-bid meeting or within 10 days from the date of publication of Tender Enquiry (Whichever is earlier) would be entertained. All queries and representations received after the aforesaid period would not be entertained.
39.	The bidder should furnish an undertaking APPENDIX-II of this NIT stating that he/she is not connected in any manner with any other bidder in this tender with respect to manufacturing, distribution, supply, in sharing business information/documents price of the item etc for the items quoted in this bid. If this is found to be incorrect, his/her tender would be rejected.

Specification/QRs for bullet-proofing of Land Rover

Being a sensitive nature item, QRs/Technical specifications for Bullet Proofing of Land Rover are not being uploaded on website. QRs would be handed over to only those concerned firms which have Department of Industrial Policy & Promotion (DIPP) license duly obtained from Government of India, Ministry of Commerce & Industry for the subject purpose and on their written request in their official letter signed by either head of the division or equivalent officer authorised for doing so. The letter must contain proper identification of the company i.e. registration details etc. The letter signing authority must also sign in non disclosure letter to J&K Police clearly stating that such QRs will only be used for their in house research in production. Unauthorised possession/circulation of same will invite legal action against them. Also they will sign a non disclosure of protection level or any other information in any print, electronic media and the same will not be digitally transacted in any form for any purpose.

The hard copy of Specification/QRs will be handed over by the AIG (Provision-Transport) PHQ J&K in person to the concerned officer only after verifying the credentials as mentioned above including their production of certificate that they are in a position either themselves or through a joint venture/consortium with India OEMs for After Sales Service, Maintenance and Repairs in J&K (at least one each such Field Repair/Maintenance Facility in Jammu and Kashmir regions). The vendor/firm will also be bound by a condition in the contract that they are in a position to provide Product Support in terms of service and maintenance, materials and essential spares for a minimum period of 10 years. Even after the said mandatory period, the vendor would be bound to give at least two years notice to J&K Police Department prior to the closing the production line so as to enable a Life Time Buy for all spares before closure of the said production line.





1.	Financial Bids of only such bidders whose technical bids are found to be genuinely in order and substantially responsive shall be opened at a subsequent date to be intimated in advance, to such eligible bidders.
2.	The rate tendered for fabrication/conversion should be both in words and figures.
3.	The tenders should be filled in, neatly/clearly, with one ink.
4.	No alterations, over writings should be made in the tender.
5.	No conditional tender shall be accepted.
6.	The successful tenderer shall have to draw an agreement on prescribed proforma (immediately after the issue of Supply Order) and deposit 10% of the contract value, as security for the due Performance of the contract.
7.	The security money will be refunded after satisfactory completion of the agreed contract. No interest shall be paid by the department on such deposits.
8.	The charges of stamp etc shall be paid by the supplier while executing the agreement.
9.	Payments shall be made by the purchasing officer against each consignment of fabricated/converted vehicle, delivered, inspected/ accepted and properly taken on the stocks in the concerned stock registers of the department.
10.	Bank commission on payment made to the firm will be borne by the supplier/fabricator.
11.	No advance payment shall be made.
12.	The fabrication/conversion so carried out shall be as per specifications circulated with the NIT.
13.	In case of any dispute between the supplier and the purchasing officer, the decision of the DGP J&K will be final and binding on the parties
14.	If after the registration/placement of orders, the tenderer backs out or fail to fabricate the vehicle, the security deposit will be forfeited, besides any other remedy that will be available to the department, under law in force, for the time being in the state.
