For and on behalf of the Governor of Jammu & Kashmir State, e-tenders are hereby invited from original manufacturers or their authorized dealers having authorization from the original equipment manufacturer to quote against this tender for supply of photography equipments required by Crime Branch Hqrs J&K under modernization of Police Force 2017-18. A pre-bid meeting shall be held on 15.07.2019 at 1100 hours for clarifications of queries of the prospective bidders if any. The intending bidders shall attend the meeting well in time at conference Hall State Crime Branch Hqrs Near Exhibition Ground Srinagar


