## NOTICE

**Subject:- e-NIT No. 38 of 2019 dated 10.07.2019, floated for bullet-proofing of Land Rover.**

Police Hqrs. J&K received some observations/queries from intending Tenderers with regard to e-NIT no. 38 of 2019 dated 10.07.20019, floated for bullet-proofing of Land Rover. A report on the said observations/queries has been obtained from Technical Committee constituted by PHQ J&K for the purpose.

All the intending Tenderers are hereby notified about the outcome report, **which is mentioned below**. The said report shall mutatis mutandis form part of the said e-NIT and deemed to be an amendment to the e-NIT wherever applicable. The other terms & conditions of the e-NIT shall remain unchanged.

1. **Protection:** The Protection Level of Armoured Land Rover must be NIJ III as per international/MHA GOI/BPR&D Standards.
2. **Safety:** The maximum possible part of Land Rover has to be protected e.g. Battery etc. wherever possible.
3. **Visibility:** The visibility of Bullet Resistant Glass should not be less than 70%.
4. **Side Mine Blast:** Side Mine Blast will be conducted with 15 Kg. TNT equivalent charge placed on the sub-ground/ground at 3 meters from the vehicle.
5. **Technical Specification of vehicle:** Police Hqrs. J&K has already purchased one base vehicle Land Rover Discovery 3.01 Diesel 4WD, Auto 5 Door HSE, VIN No. SALRA2AK5JA071117, which has to be armoured.
6. **Tyres:** The Armoured Land Rover should be provided with Run Flat Tyres. The test will be conducted as per FINABEL Standard for 50 Kmts.
7. **Cameras:** 360 degree Cameras in miniature form are to be provided, without much change in original appearance/design of the Land Rover.
8. **Welding:** The adhesive of reverting laddering of hard nature must be applied. The material used must be the same approved/used for such type of fabrications nationally/internationally.
