Subject:- Vigilance clearance.

PHQ is in receipt of huge number of service records from the subordinate formations for functional/grade promotion and other purposes for which NOC is mandatory from Director ACB J&K. The information was earlier conveyed by ACB within a fortnight.

Now the **Electronic Vigilance Clearance System (EVCS) Portal** has been established to speed up the issue and the chain of communication is via Home Department, GAD to ACB and vice versa. After operation of this procedure, it has been observed that it takes more time than the earlier one, as a result, the DPCs are delayed.

In this regard, I am directed to request that some mechanism may be put in place so that time duration is reduced to minimum level.
